- Payment in CHECK of reservation deposit equivalent to five percent (5%) of the Offer Price, simultaneous with the submission of this Offer, to BDO, is required. Otherwise, BDO shall have the right not to consider this Offer for evaluation.
- Upon BDO’s approval of this Offer, the reservation deposit shall automatically form part of the Purchase Price, and the full balance shall be paid within five (5) business days from approval notification, In case of BDO’s disapproval of the Offer or of the Auto Loan application, the check for the reservation deposit will be returned without interest. Buyer shall claim said check within three (3) business days from advice of disapproval. Unclaimed checks shall be marked “CANCELLED” thereafter.
- **If purchase is thru BDO Auto Loan, Buyer shall submit the loan application and comply with the requirements within five (5) business days from submission of Offer; otherwise, BDO shall have the right not to consider this Offer for evaluation.**
- Should the Offer be withdrawn or cancelled for any reason, despite BDO’s approval, the reservation deposit shall be forfeited in favor of BDO, after fifteen (15) working days from date of approval, without need of further notice to Buyer of such forfeiture.
